

The Ulerawa programme is a ‘case bundled system’ , designed by the Ekiti State Health Insurance Scheme (EKHIS) under the Ekiti State Ministry of Health and Human Services, to provide universal health coverage to residents of Ekiti State, with a particular focus on ensuring that the most vulnerable members of the population have access to quality health care services.

Ulerawa aims to scale up access to a comprehensive package of high impact primary care package, focusing on providing reimbursement to health facilities based on the delivery of a suite of high impact health interventions that addresses 73% of the disease burden in the State.



Free Health Services Provided

Ulerawa provides free health services such as:

Consultation

Laboratory tests

Antenatal and Post-Natal Services

Child Delivery

Family Planning

Child Care and Nutrition

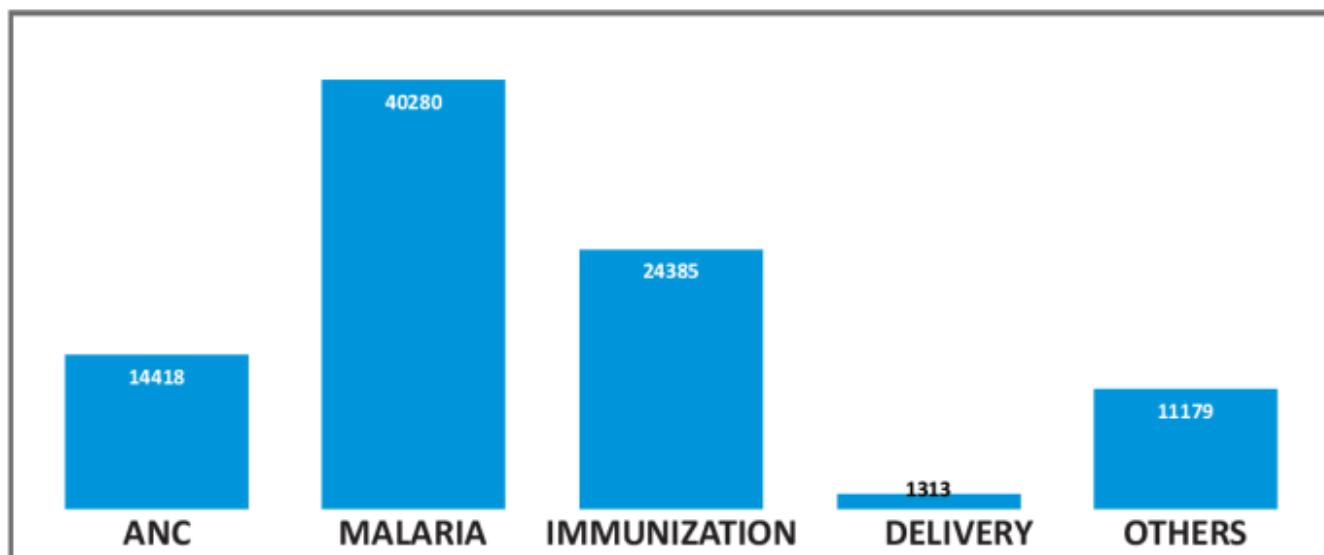
Diarrhoea and Pneumonia Treatment

Immunisation/Vaccination

Malaria Treatment

Ulerawa have recorded 1313 deliveries and immunized over 24,000 children, with over 11,179 of the claims services that include: URTI treatment, diarrhoea, family planning, micronutrient deficiency and many others.

The Scheme had scaled up the services of the program to all the accredited 177 facilities in

Ekiti State in August 2023 and enrollees have started accessing care in these expanded facilities. The program has a goal of covering 500,000 lives in the state. The Scheme received 91,575 claims in from the various facilities across the 16 LGAs in the State as the September, 2023. The Scheme had record 91,575 claims so far where Ado LGA has the highest number of claims (11,838) closely followed by Ekiti East (10,557).

The lowest number of claims was recorded in Ilejemeje LGA the 976. It is also noted that Ado LGA was part of the Phase-1 LGAs that first implemented the programme. It was discovered that sensitisation Community mobilization in Ado, Ekiti East, Oye and Ido/Osi LGA were very high.

The highest number of claims (4036) was recorded in CHC Okesa in Ado LGA, while 2133 and 2070 claims were recorded in CHC Omuoook and BJC Iludofin in Ekiti East LGA. The lowest number of claims were recorded in facilities from Ilejemeje LGA and Ekiti West LGA. 91,575 claims were received from various facilities where malaria service is 43% of claims received.
